

PANCAKE MANOR ANNUAL PANCAKE EATING COMP 2019

Terms and Conditions



1. Eligibility

Australian residents aged 18 years or over are eligible to enter this Promotion. Employees of the Promoter are not eligible to enter this Promotion. Persons under the age of 18 may enter only with the consent of their parent or legal guardian. If such consent is not given, the entry will be deemed invalid and any prize forfeit for a redraw.

2. Entry

By entering this Promotion, the entrant accepts these terms and conditions. A person may only enter this Promotion once and must enter this Promotion during the Promotion Period. In order for the Promoter to notify the winners, the entrant must provide his or her full name and e-mail address. The Promoter may deem an incomplete entry invalid if this information is not provided. To enter, entrants must go to either Pancake Manor location (Charlotte St, Brisbane or Westfield Garden City, Qld) and pay a AUD\$9 entry fee for the Annual Pancake Eating Competition. They must eat as many pancakes as they can within the one hour time period as dictated by the individual store.

3. Prize

The prize will consist of 1 year's worth (1 x regular stack per week, with either butter or cream & ice cream) of pancakes from the Pancake Manor at the Pancake Manor location the prize was won at. The total prize pool will be valued at up to \$517.40. Prize is not transferable or exchangeable and cannot be substituted for cash. If a prize is unavailable, the Promoter may substitute that prize with a prize that is equal in value or type. Prize of a year's worth of pancakes at Pancake Manor equates to 1 regular stack per week for 52 weeks. Prize begins from the Monday after winning the prize (11th March 2019) and you can only redeem your weekly regular stack of pancakes at the Pancake Manor location you won the prize at (i.e. If you are the winner at Pancake Manor Garden City's Annual Pancake Eating Competition, you can only redeem your year's worth of pancakes at Pancake Manor Garden City – prize is not transferrable between locations). The prize will be 52 individual vouchers, each for a regular stack (equating to one for each week of the year), however they will be divided up to be valid for one month periods (i.e. There will be 3 vouchers valid for March 2019; 4 vouchers valid for April 2019). If the weekly pancake stack is unused in one week it can be carried over into the next week of that same month (i.e. You can use all 4 vouchers for April 2019 in one sitting during April 2019, however you cannot use 4 April vouchers and 1 March voucher in one sitting in April 2019). Friends and family can redeem the prize provided they are with the winner at the time of redemption. Any accumulated weekly regular stack must be used within the month of validity on the voucher. Any unused vouchers/stacks become void.

4. Selection

The winner of the prize will be chosen by the Promoter. This is a game of skill and the winner will be chosen by the Promoter based on the results of the Annual Pancake Eating Competition. All contestants must have paid the \$9 entry

fee, and arrive at the respective Pancake Manor location before the start of the competition. Pancake Manor Garden City's competition will be on Saturday, 9th March 2019, at 3pm AEST. Pancake Manor Brisbane City's competition will be on Sunday, 10th March 2019, at 4pm AEST. They then must eat as many buttermilk pancakes as they can within the 1-hour time frame. There are no toilet breaks allowed. There is no sharing allowed. Only whole pancakes count (partial pancakes and crumbs do not count). Eaten pancakes must stay down for the duration of the competition - if any food is regurgitated, the contestant is eliminated from the competition. If a winner has not paid the entry fee then the prize is forfeit. The winner will be the contestant who has eaten the most whole pancakes within the designated 1-hour time period, and abided all the rules aforementioned. The judge's decision on the day is final. The selection for the prize will take place at the location of the Promoter's competitions at the end of the 1-hour Competition Period.

In the event of a tie where more than one contestant has consumed the most pancakes in the event; there will be a second contest immediately after whereby the tied contestants must consume a regular stack each whilst being timed. The contestant who consumes the regular stack in the shortest amount of time, whilst adhering to the rules of the original competition, is the winner.

5. Winner

The winner of the prizes will be announced at the Promoter's locations after the competition finishes, approximately 4pm AEST on Saturday 9th March 2019 and 5pm AEST Sunday 10th March 2019, for each respective location. The winner will be the contestant who has consumed the most pancakes within the given time period and rules. The winner of the prize must sign any release form that may be required by the Promoter or supplier of a prize. After announcement of the winner, the Promoter will present the prize to said winner.

6. Unclaimed Prizes

If a prize is unclaimed, the Promoter will announce the second place contest as a winner for the unclaimed prize 3 months after the initial contest and will notify the winner via phone or email if details are given; and/or via Facebook announcements on the Pancake Manor Facebook page. The selection will take place at the Promoter's office.

7. Forfeited Prizes

The Promoter may forfeit a prize if a winner refuses to sign any release form specified in section 5 or a winner refuses to accept a prize.

8. Entrant's personal information

By entering this Promotion, the entrant consents to:

a. the Promoter, or any of its affiliated entities, using the entrant's details for future marketing and promotional purposes, except if notified otherwise by the entrant;

b. if entrants are winners, the Promoter using their name, likeness, image and

voice in any media platform; and

c. disclosing the entrant's personal information to third parties, including agents, contractors and suppliers of the Promoter.

9. Promoter's Rights

The Promoter may verify the validity of entrants (including an entrant's identity, age and place of residence). The Promoter may disqualify an entrant who submits an entry that is not in accordance with these terms and conditions or who tampers with the entry process. The Promoter may either disqualify an entrant or modify, suspend, terminate or cancel this Promotion if this Promotion is interfered with or this Promotion is not capable of being conducted as reasonably expected due to a reason beyond the control of the Promoter, including technical difficulties, unauthorised intervention or fraud.

This promotion is not sponsored, endorsed or administered by, or associated with, Facebook, Instagram, Westfield Pty Ltd or Scentre Group. The Promoter releases Facebook and Instagram from, and indemnifies Facebook and Instagram against, any claim, action, demand or suit arising from, or connected to this promotion.

10. Promoter's Liability

The Promoter is not liable for any discomfort, loss, expense, damage or liability that may be suffered or incurred by a person in entering this Promotion or accepting and using the prizes. If the Promoter is liable, the Promoter's liability is limited to either resupply of the goods or services. This section 10 does not alter a person's rights under the Australian Consumer Law.
